

Cards International Limits

In light of the recent instructions of the Central Bank of Egypt, it was decided to follow the below steps pertaining to credit cards international limits:

- Cardholders to submit request to activate credit card's international spending limits through our Call Center on 16222 or by visiting any of Attijariwafa bank Egypt's branches.
- In case cardholder is already outside Egypt, they can contact our call center on (+202)
 25291300
- International spending limits will be enabled based on travel duration requested and Card Type.
- International limits are subject to change at bank sole discretion.
- Cardholders will be requested to submit a copy of the departure and arrival stamps on their
 passport, a copy of the passport's first page and the credit card last 4 digits within 90 days
 from limits activation through the email group Traveldocs@attijariwafa.com.eg
- In case the customer stays abroad for a duration exceeding 90 days, supporting documents
 must be sent to the bank proving the customer's presence abroad before the end of the
 specified duration.
- If the above-mentioned documents are not submitted within the 90-day period of activation of the international spending limits or proof of exceeding 90 days abroad, the following will occur:
 - Credit Card will be suspended
 - Cardholder will be included in the negative list in the Egyptian Credit Bureau "I-Score".

Important Highlights:

- For newly issued credit cards as of 24 December, 2023, international transactions will not be allowed for a duration of 2 months from the date of issuance.
- International credit cards spending will be restricted to certain merchant categories, for example: Jewelry.
- Please do not use your cards in commercial or unusual transactions abroad. It is also
 prohibited to allow anyone (other than the card owner) to use the card abroad instead of
 him/her, in order to avoid stopping transactions on the card.
- Please note that the international usage for debit cards on EGP accounts have been suspended.
